- 2 If you are accessing or using our Sites on behalf of an entity, then (a) you represent and warrant that you are authorised representative of the entity with the authority to agree to these Terms of Service on the entity’s behalf; and (b) you agree and acknowledge that your entity is responsible for its representatives’ access to and use of our Sites and participation in the SingEx Community.

SINGEX COMMUNITY GUIDELINES

- 6 We do not endorse or represent that any material or content on our Sites is accurate, useful, non-harmful, or in compliance with our Community Guidelines. As it is impossible for us to review all material and content on our Sites, we shall not be liable or responsible for any loss or damage arising from any access, use or download of any material or content on our Sites.
- 7 We reserve the right to moderate, delete, edit and/or modify any material or content and/or close any topic on our Sites at any time without notice to you. LIMITATIONS OF ACCESS TO OR USE OF OUR SITES

INTELLECTUAL PROPERTY

10 SingEx IP

- (a) All rights, title and interest in and to intellectual property rights including content, documents, software, images, text, graphics, illustrations, logos, patents, trademarks, service marks, copyrights, photographs, audio, videos, webinar, webinar reference materials, music, “look and feel”, and other proprietary rights including all adaptations, derivations and variations (“**IP**”) relating to our Events and on our Sites are either owned or licensed by us (“**SingEx IP**”) and may not be copied, displayed, distributed, downloaded, licensed, reproduced, sold, transmitted, used or otherwise exploited for any purpose not authorised by us in writing. Other than the limited grant of access to view and, with our permission, to download the SingEx IP, you shall have no privileges or rights in any SingEx IP, unless we otherwise agree in writing.

11 Your IP

in the SingEx Community (“**Contributions**”), unless otherwise agreed between you and us in writing, are owned or licensed by you.

- (b) You agree to grant us a fully-paid, irrevocable, non-exclusive, perpetual, royalty-free, worldwide licence, with sub-licensing rights and without duty to account to use, access, download, copy, distribute, transmit, modify and adapt your Contributions (i) to enable us to discharge our obligations under these Terms of Service and/or other contracts between you and us; (ii) for the purposes of displaying, distributing, and promoting our Events, Sites, products and services, including making recordings and copies of your Contributions or portion(s) of them available for viewing and downloading by the public; and (iii) for any other purposes in connection with our Events, Sites and SingEx Community activities, including future events, industry news, global roadshows and online sessions (collectively the “**Purposes**”), unless we otherwise agree in writing.
- (c) You agree to grant to us a non-exclusive, fully-paid, non-transferable, non-sublicensable and limited licence to use your Pre-Existing IP for the Purposes, unless we otherwise agree in writing.
- (d) You represent and warrant that your Pre-Existing IP and Contributions do not infringe the IP rights of any third party and that you own all rights in your Pre-Existing IP and Contributions.
- (e) If your Contributions contains IP of a third party, you agree to obtain all written permissions or clearances, and sub-licensing rights required by the owner of the content or material or any other individual or organisation to use and provide such Contributions to us in accordance with these Terms of Service, and provide to us supporting evidence and documents. You must display attribution text or citations in such Contributions, attributing the original owner.
- (f) We reserve the right to delete, take down, edit, moderate and/or modify any Pre-Existing IP or Contribution used or provided by you on our Sites at any time, and the right to monitor, intercept and/or review any Contribution on our Sites, without notice to you.

HYPERLINKS

- 12 We and/or others within the SingEx Community may provide hyperlinks to other third party sites (such as social media platforms) which may not be owned, managed or operated by us (“**Third-Party Sites**”). We do not have any control over those Third-Party Sites and shall not be liable or responsible for the accuracy, availability, content or functionality of such Third-Party Sites and the contents, products and services provided therein, or for any loss and/or damage arising from your access or use of such Third-Party Sites.
- 13 Hyperlinks to Third-Party Sites provided by us and/or others within the SingEx Community do not mean that we are connected with, related to or associated with or endorse the Third-Party Sites and the contents, products and/or services provided therein. Such Third-Party Sites may have their own separate terms and conditions and/or policies.
- 14 You should exercise caution and good judgement before providing or clicking on hyperlinks to Third-Party Sites, as this could expose the SingEx Community to possible viruses, worms, Trojan horses, and other harmful or destructive content.

EVENT REGISTRATION

- 15 Admission to our Events is by registration only and subject to full payment of the applicable fees being received by us prior to the commencement of the Event. Registration fees may be changed by us from time to time without prior notice and without us giving any refund. We reserve the right to withdraw, cancel, amend, extend or shorten any promotion and/or discount offered at any time without prior notice.

- 16 All passes purchased by you and/or issued by us are non-refundable and non-transferable, unless otherwise specified by us in writing. No refunds will be given for cancellation or downgrading of any registration, passes or any other purchases, non-attendance of the Event, or for any other reason. We reserve the right to retain, confiscate or void any pass without any liability to make any refund, and are not obliged to replace any pass under any circumstance.
- 17 We may vary, alter and/or modify the venue, format, programme, attractions and features, dates and timings (including postponing, shortening or extending the duration) of any Event at any time and/or to cancel the whole or any part of any Event by notifying you as soon as reasonably practicable.
- 18 By registering for any of our Events and/or purchasing a pass, you agree that your business profile, business contact information and preferences may be shared by us within the SingEx Group and with the SingEx Community to keep you connected with the SingEx Community and updated on all activities, in accordance with our Privacy Policy at our Sites and <https://singex.com/>. Where any data of a third party (for example, information of your family members or employees) is provided by you for any particular purpose including registering and/or purchasing passes for the Event, you must seek his or her appropriate consent before you provide us with such data.

 - (b) Passes shall not be purchased or obtained from or through any commercial agent or company or otherwise than directly from us or our appointed agents.
 - (c) Passes shall not be used for advertising, promotional or commercial purposes (including trade incentives, prizes, competitions, contests, sweepstakes, raffles, lotteries, or draws, whether for commercial or charitable purposes) without our prior written consent.
- 21 We reserve the right to refuse acceptance of registration, refuse entry or remove any person into or from the Event and/or any Site without giving any reason.
- 22 Additional registration terms and conditions may apply. Please refer to the specific registration terms and conditions on our Sites, if any. In the event of any inconsistency or conflict, the specific registration terms and conditions on our Sites shall prevail.

SPEAKERS

- 23 If we have selected you as a speaker, you agree to speak at the specified Event live, via a live stream webinar, video recording or otherwise specified by us ("**Presentation**"). You acknowledge the possibility of taking on additional related roles in the Event, including moderating a session or delivering additional Presentations, depending on the needs of the Event. We reserve the right to postpone or cancel your speaking engagement at any time without incurring any liability.
- 24 Substitute speakers for the Presentation are not allowed without our prior written consent. If you are unable to fulfil your Presentation commitment due to extenuating circumstances (for example, hospitalisation or personal emergencies), you must notify us as soon as possible. Should you fail to fulfil your Presentation commitment for any specified Event without valid reasons, we may disqualify you from any future edition of the specified Event and our other Events.

- 25 You are not allowed to change the topic or outline of your Presentation and you are to commit to adhering to the description of the Presentation you have provided to us, unless we otherwise agree in writing. You must submit to us your final Presentation material (such as slides, handouts or videos) which you will be using during your Presentation. Please refer to our IP terms above.
- 26 Visa requirements, accommodation, travel costs and any other expenses incurred by you in relation to the Event and/or Presentation are your sole responsibility and we will not reimburse you for any of the same, unless otherwise agreed by us in writing.
- 27 Your Presentation must be in English and not violate our Community Guidelines. We reserve the right to modify, vary or edit any material of your Presentation prior to publication but we will, where practicable, provide you such material so modified, varied or edited prior to our publication. You agree to waive all your moral rights for such purpose. You must not represent any of your views (whether as part of the Presentation or otherwise) as being those of or shared by the Event, us or others within the SingEx Community, or any of our/their affiliates, officers, agents or employees.
- 28 Additional speaker terms and conditions may apply. Please refer to the specific speaker terms and conditions on our Sites, if any. In the event of any inconsistency or conflict, the specific speaker terms and conditions on our Sites shall prevail.

USER ACCOUNTS & COLLABORATIONS

- 29 User accounts
 - (a) To register or sign-up for a user account, you must have a valid email account and be at least 18 years old. Minors may only access or use our Sites under the supervision of an adult. You may have to verify your email address before you can access your user account.

- (e) We disclaim all warranties and representations of any kind, express or implied, including that (a) any Collaboration and the related contents and materials are accurate, appropriate, available, complete, timely or updated; (b) we are connected with, related to or associated with or endorse any Collaboration or those involved in the Collaboration, and the related contents, products and/or services; (c) any submission of expression of interest for a Collaboration will be assessed or reviewed by us; and (d) any person will be identified, selected, connected and/or matched with any other person in respect of any Collaboration.

31 Additional terms and conditions of certain services on our Sites may apply. Please refer to such specific terms and conditions, if any. In the event of any inconsistency or conflict, the specific terms and conditions of the particular service on our Sites shall prevail.

FORCE MAJEURE

32 We are not liable for any interruption to our Sites, delay, damages, loss, increased costs and/or other unfavourable conditions directly or indirectly arising by virtue of any cause beyond our reasonable control, including without limitation, fire, flood, illness, pandemic (as declared by the World Health Organisation), power failure, communications line interruption, technical and computer-related faults and breakdowns, server outage, website vandalism, computer virus invasion or attack, hacker attack, temporary or permanent website closure or shutdown (caused by governmental control or otherwise), earthquake, explosion or accident, blockade, embargo, inclement weather, governmental order, decree, restraints or regulation, restraints or orders of civil defence or military authorities, war, riot or civil disturbance or commotion, sabotage, act of terrorism, strike, lockout, boycott or other significant labour dispute or disturbance, absence of premises required for our Events, and the abovementioned scenarios shall include any threat thereof.

DISCLAIMER OF WARRANTIES AND EXCLUSION OF LIABILITY

- 35 We shall not be liable for any damage or loss arising from your access or use of our Sites and/or your reliance on the information contained in our Sites.

INDEMNIFICATION

- 36 You agree to fully indemnify, keep fully indemnified and hold harmless us, our affiliates, directors, employees, agents, successors or assigns from any losses, claims, demands, liability, costs, expenses, actions or threat of action arising from or in connection with your breach of these Terms of Service, in connection with your access to or use of our Sites, and your violation of any law.

SEVERABILITY

- 37 If any provision or any part of a provision in these Terms of Service is held invalid, illegal or unenforceable by a court of law or a tribunal, it shall be deemed modified to the minimum extent necessary to give effect to our commercial intention. The validity, legality and enforceability of the remaining provisions or remaining parts of a provision shall remain in full force and effect.

ENTIRE AGREEMENT

- 38 Your agreement with us constitutes the entire agreement on the subject matter between you and us and supersedes all prior agreements, negotiations, statements, representations and discussions (whether oral or written) in relation to the agreement ("**Representations**"). You acknowledge that you have not entered into this agreement in reliance on any Representation, and that you will not have any claim, right or remedy arising out of any such Representation.

ASSIGNMENT

- 39 You may not assign or transfer any benefits, rights and obligations under these Terms of Service to any third party without our prior written consent. We shall be entitled to assign or transfer any benefits, rights and obligations under these Terms of Service to any third party (including our subsidiaries, associated companies or affiliates) without your prior written consent.

WAIVER

- 40 None of the provisions or part thereof of these Terms of Service shall be deemed to have been waived by any act or acquiescence on our part, our agents or employees, unless by an instrument in writing signed by us. No waiver of any provision of these Terms of Service shall constitute a waiver of the same or any other provision(s) in these Terms of Service on another occasion.

NOTICES

- 41 Any notice and/or communication in connection with these Terms of Service shall be in writing to the contact details including specified email addresses as notified by the relevant party. Handwritten or electronic signatures transmitted by telecopy or electronic transmission (for example, through use of a "PDF" file) shall be valid and effective to bind the party so signing.

CHANGES TO OUR SITES AND TERMS OF SERVICE

- 42 We may from time to time change any part of or information contained in our Sites and/or update these Terms of Service by posting in this Site with the stipulated date of update. If we make material changes to these Terms of Service that affect the way you access or use our Sites, we will notify you specifically if required by law.

EXCLUSION OF THIRD PARTY RIGHTS

- 43 A person who is not a party to your agreement with us shall have no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B of Singapore) to enforce any of its terms.

GOVERNING LAW AND JURISDICTION

- 44 These Terms of Service shall be governed by and construed in accordance with the laws of Singapore and shall be subject to the exclusive jurisdiction of the Courts of the Republic of Singapore.
